**2018 Spring Rocket Camp Rules and Regulations**

1. Rocket Camp is from 8am - 5pm on Tuesday and Wednesday, April 3 and 4, 2018. The cost is \$57 for in-parish residents and \$68.40 for out-of-parish residents. Parents can drop off children as early as 7:30am and pick up children as late as 5:30pm. *Because day camp supplies are purchased in advance based on registration numbers, refunds are not allowed unless the camp is full and someone is available on the waiting list for replacement.*
2. Make sure your registration form is complete. In case of emergency, BREC will not be responsible for lack of guardian notification due to insufficient or inaccurate information on registration form. *If any information changes, it is the parent/guardian's responsibility to make changes on the registration form.*
3. Falsifying information on the registration form could result in the child's dismissal from camp with no refund.
4. Parent/guardian *must* walk into the building each day to sign in and sign out the child. Sign-in/sign-out forms are available with the camp counselor on duty.
5. No child will be allowed to leave camp with anyone other than his/her parent/guardian without *advanced written permission from parent/guardian.*
6. We strongly discourage a child bringing money. All activities are paid with the registration fee. BREC is not responsible for lost money, games or other personal items brought to camp.
7. Camp staff is not allowed to dispense any medication to campers except basic first aid. The child is responsible for taking his/her own medicine. Parent/guardian *must* notify Observatory Manager of child taking medicine. Medicine must be labeled clearly with child's name, names of medication and dosage level.
8. Drop-off/pick-up times will be strictly enforced. Abuse of early drop-off/late pick-up can result in child's dismissal from camp. For any unforeseen problem affecting this policy parent should contact camp staff immediately with explanation.
9. BREC considers attending camp a privilege and will not tolerate unruly or disruptive behavior from any of its campers. If any child becomes a discipline problem, he/she may be subject to dismissal from camp. Parents/guardians are expected to work with camp staff in the discipline of their children. Depending on the severity of the incident, a camper can (a) be given a verbal warning, (b) be placed in time-out, (c) have an activity taken away, (d) be dismissed from camp.
10. Campers must be prepared to spend most of the rocket launch outside in the Sun. We recommend each camper bring a water bottle, hat sunglasses and sunscreen that are labeled with his/her name. Close-toed shoes are required.
11. Campers must have lunches and two snacks each day that do not require refrigeration. Water and juice are preferred over carbonated drinks. No chewing gum or gummy candies allowed.
